Some of these memories are preconscious, which means they are accessible to consciousness, which is a kind of inner sense organ. Other memories or ideas are unconscious because they are kept out of consciousness by repression or other defense mechanisms because awareness of these memories or fantasies would cause painful feelings of fear, shame, or guilt. Thus, in Freud's new model, he described the topography of the human mind, with unconscious, preconscious, and conscious areas. In terms of the latest structural model Freud mentions in his book *The Interpretation of Dreams*, Freud tries to combine two models from his earlier topographical model of the mind by allocating his concepts of conscious, preconscious, and unconscious processes, of drives and defenses with primary and secondary processes, etc., to three agents: id, ego, and superego/ego ideal.

Among the three concepts of mind, the preconscious one took a center role between the other two concepts. This concept float between the conscious and unconscious state and carry the unaware feeling and thoughts that can be called into both state of minds as quoted by an article on verywellmind.com (2022), "The subconscious mind is between the conscious and subconscious mind and includes information that is not actively in consciousness but can be easily brought into consciousness when needed." The model mentioned above is a developed mechanisms for interpreting the hidden meaning of a text. It helps in understanding symbols, actions, metaphors, and complex settings in literary works and can be applied to any literary work (Chernys, et. al., 2021).
